

Conditions of Entry

- Exhibitors must be Full Financial Members / Associate Members of the Gold Coast Potters' Assoc. on or before February 28 2010.
- Entry Forms (including Catalogue details) accompanied by the appropriate Fee must be received by the due date. Late entries will not be accepted.
- The work submitted must be your own, original work, made in the last 12 months.
- No commercial moulds are to be used.
- Work must be suitable to exhibit safely e.g. work must be stable.
- All work must be for sale. A commission of 25% of the Retail Price will be charged for any works sold.
- While every care will be taken with your work, it is your responsibility to arrange insurance if you see fit.
- Each exhibitor is required for Roster Duty during the Exhibition. Those who do not do their rostered duty may be excluded from future Exhibitions.
- Student or Hobby Potters who have not previously provided a Statutory Declaration must fill in a "Statement by a Supplier" Form when they deliver their work.
- All work must remain for the duration of the Exhibition.
